DECLARATION / UNDERTAKING BY THE STUDENT AND PARENT / GUARDIAN

- 1 I declare that I have read the contents of the prospectus and supplementary brochures and understood the contents fully. Accordingly I am seeking admission into CITY Engineering College on my own interest and accord.
- 2 I declare that, all the information furnished in this application form is correct to the best of my knowledge. If found to be incorrect or false, I may be refused admission or debarred from the college. If admitted to CITY Engineering College, I agree to abide by the policies, rules, bylaws and regulations of the college, as amended from time to time. If found violating the college rules and discipline I shall be debarred from the college and the decision of the college shall be conclusive and final in this regard my admission to the BE course is subject to approval of Visvesvaraya Technological University (VTU). Even if VTU does not approve
- 3 My admission for want of required original certificates to be submitted by me within the last date and if I am not eligible due to non recognition of my PUC/ Intermediate/ 10+2/ by VTU or if I discontinue the course on my own I fully understand that the fees paid will not be refunded by CITY Engineering College as the college has already provided me the seat (otherwise the seat would have gone to another deserving student). Certificates submitted for approval will not be returned to me unless I pay the full course fee for all four years and also the certificates will be under the custody of VTU until the course is completed. Fees applicable for my batch is to be paid for the entire course, irrespective of fees fixed for the senior and junior batches.
- 4 Lagree to the rule that deposits, of any kind both at the college and hostel will be refunded only after the completion of the course and Liwill not request for any refund, even if Liwithdraw admission or vacate the hostel room. Lagree that, the entire amount shall be forfeited under such situations.
- 5 I declare that I shall not indulge in ragging, eve teasing, smoking, consuming alcohol, use of drugs or any other anti-social activities in the college premises, hostel, on educational tours, industrial visits or elsewhere. I shall abide by the dress code prescribed by the institution.
- 6 I understand that once, I am admitted to the college, I am required to pay the total and full fees for all four years (entire course) at the time of admission. However, considering my request the college has agreed to take fees by installments. Since the seat has been provided to me, the same cannot be allotted to any other prospective student at a later date, as my discontinuation of study is a financial loss to the college. Hence I have to pay full fee for all years and collect my original certificates. I also declare that I have not paid any donation or capitation in any form to the college against admission.
- 7 I understand that all information will not be sent to me by mail and I am required to pay the college fee, exam fees etc., by following college notice board and fees to be paid through challan into the Bank and obtain the receipt from college. I understand that my name will be entered in the attendance register only after the payment of fees in full and 80% attendance will be calculated for the university exams from the date of payment of fees.
- 8 I understand that it is my sole responsibility to submit my entire educational qualifying certificates or provisional degree certificate (Date of Birth/ Class 10th Marks Statement/ Class 12th Marks Statement/ Transfer Certificate/ Migration Certificate/ No objection Certificate/ Eligibility Certificate in case of foreign students etc.,) to the college at the time of admission itself.
- 9 Though the college may granted me provisional admission in the absence of some of the certificates on my promise of submitting them at a later date, if all the required certificates are not submitted by me within 15 days of admission, my provisional admission shall automatically gets cancelled and I shall not be entitled for any refund of fees paid by me as the college has already provided me a seat. I also understand that all disputes, differences and legal matters are to be settled within the Bangalore City jurisdiction only.
- 10 I undertake that I will not indulge in any type of illegal activity which is against to the rules and regulations of the college, VTU, AICTE.
- 11 It is also made aware that my college Tuition fee & other fees (Outsourced service/facilities) is to be paid within the specified date/commencement of academic year, then only attendance will be taken into consideration from the said date, failing which it is to be treated as absent to the classes, resulting violation of University rules and I am liable for the consequences.
- 12 In the event of my withdrawal of admission to join any other college or by getting a seat through CET/PGCET, or for any other reason, once I collect my original certificates by agreeing that I will not get any refund of fees, I will not claim the refund or will not go to court of law at a later date.
