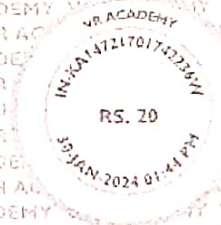
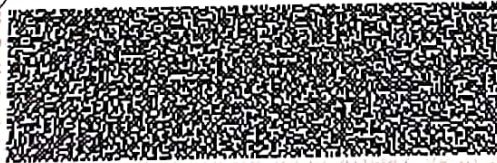
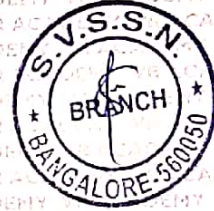

Hereafter referred to as **VR Academy** and **CITY ENGINEERING COLLEGE**, here in after referred as **CEC** believing that the process of collegiate education can be enriched and national understanding strengthened, and recognizing the benefits to their respective departments from the establishment of educational links and cooperation, conclude this agreement.

The Memorandum of Understanding (MoU) as outlined in this document is not intended to be a legally binding document. Rather, it is meant to describe the nature and cooperative intentions of institutions involved and to suggest guidelines for cooperation. Nothing, therefore, shall diminish the fully autonomy of either institution, nor may any constraints be imposed by either upon the other, and nothing in this agreement shall be deemed to create a partnership, joint venture, or agency relationship between the parties.

The memorandum of understanding shall remain in force for a period of THREE (3) year from the date of the last signature and will be renewed automatically for periods of the same duration unless it is revoked with the understanding that it may be terminated by the appropriate authorities of either party giving THREE (3) month notice to the other party in writing, unless an earlier termination date is mutually agreed upon. The MoU may be amended or extended by written consent of the two parties.

VR ACADEMY and **CEC** wishing to establish relations between both institutions; hereby agree to cooperate with each other in areas of mutual interest as follows:

1. The purpose of this agreement is to develop academic and educational cooperation and promote mutual understanding between **VR ACADEMY**& **CEC**.

2. VR ACADEMY and CEC shall strive together to provide effective learning spaces in tandem with the programmes offered by CEC.
3. VR Academy shall endeavor to provide Value Added Courses and Skill Courses as per the broad vision of the NEP-2020 and it shall make efforts to align the same according to industry demand and as per University/UGC/AICTE requirements. The courses may be sponsored, partly funded or charged. Such programmes and courses shall be announced and made available to CEC.
4. CEC shall cooperate by providing required infrastructure (Lab, Classrooms, Computers etc.), as per course requirement which is necessary for successful implementation of the desired programme.
5. Both VR ACADEMY & CEC agree and shall endeavor to promote collaborative activities in academic areas of mutual interest on a basis of equality and reciprocity, which shall be as per the scope listed below:
 - a) Promoting skill-based learning and certification as added value.
 - b) Providing lab setup as per batch size for the delivery of course.
 - c) Concluding learning outcome.
6. VR ACADEMY undertakes to support the students of the institution for internship / placement activity.
6. The terms of cooperation for each specific activity implemented under this MoU shall be mutually discussed and agreed, prior to the initiation of that activity. Any such implementation agreements will form appendices to this Memorandum of Understanding.
7. The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed between the faculties of the department which carry out the specific projects. Both institutions agree to carry out these activities in accordance with the laws.
8. Financial and/or funding considerations shall become the subject of specific discussion and agreement within the framework of a separate implementation of agreement, if any.
9. It is understood that the implementation of any of the types of cooperation stated in clause 3 shall depend upon the availability of resources, concurrence and financial support at the universities concerned.
10. Should any collaborative research activity under this Agreement result in any potential for intellectual property, both VR ACADEMY & CEC shall seek an equitable and fair understanding as to ownership and other property interests that may arise.

11. This MOU covers the current sponsored NASSCOM approved syllabus, NSDC certified future skill programme.

Notification of any change in liaison officers may be made by letter without amending this MoU Agreement.

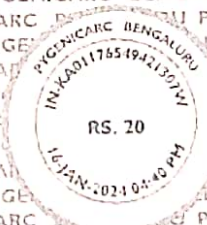
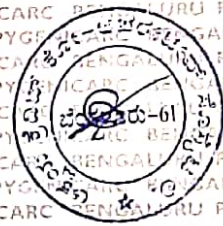

PYGENICARC Programs MoU

This Memorandum of Understanding ("MoU") is entered into on 10th January, 2024 at Bengaluru.

BY and BETWEEN

PYGENICARC, BENGALURU - having its registered office at # 203, SB Orchids view, Uttarahalli, Bengaluru - 560061 and represented by the office of the Managing Director, PYGENICARC and assignees of First Party.

AND

City Engineering College, Bangalore has its registered campus at Kanakapura Rd, near METRO Station, Doddakallasandra, Bikasipura, Bengaluru, Karnataka 560062, and represented by The Principal, hereinafter referred to as "Institution" (which expression shall wherever the context so admits include its successors in interest, faculties, administrators, management and assigns) of the Second Party.

WHEREAS PYGENICARC offer programs and courses to the institutions that are in line with VTU guidelines and designed along with industry experts for the students. Exposing students to various opportunities available in the industry to build their competitiveness will enhance the learner's 21st-century skills. Industry experts and academic stakeholders for knowledge sharing and co-creating solutions that positively impact the community.

WHEREAS City Engineering College, Bangalore with the vision to provide learning opportunities, ensure excellence in education, research and facilitate an inspiring world-class environment to encourage creativity. The institute is committed to disseminating knowledge, and through its ingenuity, brings this knowledge to bear on the world's great challenges. CEC is dedicated to providing its students with an education that combines academic study and the excitement of discovery kindled by a diverse campus community.

For the purposes of this MoU, PYGENICARC, and City Engineering College, Bangalore shall be individually referred to as "Party" and collectively as "Parties".

1. PREAMBLE

Whereas both the Parties have under this MoU agreed to collaborate with each other or jointly with third parties for enhancing learner's 21st-century skills, Future Tech, Entrepreneurial Mindset, Societal Problem Ideation, Prototyping, and IP creations. The partnership shall help in shared resources, mentors and industry experts that can aid the institution in setting up an innovation ecosystem in their region thereby enhancing the outcomes of their own institution. The mutual platform was created for students to explore, experiment and excel in their field of interest thereby enhancing the quality of learning for students which in turn helps in NBA, NAAC accreditation and NIRF, ARIIA ranking.

2. PROPOSED MODES OF COLLABORATION

- a. PYGENICARC shall curate industry-standard curriculum and training for the purpose of imparting industry-specific knowledge to the students of the First year up to the Third year at the nearest PYGENICARC Innovation Hub. Students from the institution can opt-in for the specific courses of their interest.
- b. PYGENICARC shall facilitate students of respective engineering branches of City Engineering College, Bangalore to take up internship/experiential learning through field visits, in collaboration with local stakeholders.
- c. PYGENICARC shall facilitate students of respective engineering branches of City Engineering College, Bangalore to take up workshops, webinars, hackathons, and Industry Talks with guidance from available resource persons & experts.
- d. PYGENICARC will seek assistance on occasions to connect with local or influencers or associations that shall enable better community engagements. e. IPs generated during the program will be mutually shared between the institution/organizations participating and innovators of the idea. This is done to encourage more intellectuals and organizations to participate in developing innovative ideas for the development of communities.

In addition to the above, recently the Government of Karnataka has implemented the "Skill Labs Scheme" for students of engineering colleges with the intention of training the students to be industry ready. The fee structure for each student/year will be decided by the affiliating university viz. VTU, Belagavi..

Based on the evaluation made by VTU, the fees will be fixed to individual institutions as per the eligibility criteria. Hence, City Engineering College, Bangalore has decided to collaborate with PYGENICARC, purpose of upskilling the students for the

21st Century needs, to enhance learner's skill sets. The track record of PYGENICARC with its committed trained manpower has given very good results in conducting summer internship programs for the institutions. PYGENICARC is also ready to offer skill-enhancing programs as per the proposal approved by VTU (Ref. No 3175), Belagavi. Hence, the following agreements are made between City Engineering College, Bangalore and PYGENICARC to provide quality training to the students and the same is monitored for its effective implementation.

3. RESPONSIBILITIES OF PYGENICARC

As the new NEP 2020 structure has emphasized experiential learning rather than rote learning, it is imperative to look into courses that focus on unleashing the creative potential of youth demography. With this objective, PYGENICARC has taken the below responsibilities,

- a. Design, develop and deliver the structured programs/courses in an effective way to the students.
- b. To nurture the competitiveness of the students through experiential and hands-on learning thereby enhancing the employability of the youth.
- c. To maintain and record data of the students, such as the attendance, assignments, completion of training modules, certificates, project reports, internship/ workshop/ webinars/ events attended, evaluation and the details of the trainer/ experts; submitted to Institution for official records.
- d. To enhance the skill of the students by exposing them to various opportunities available in the industry and community.
- e. To provide the certificates to the enrolled students, who complete the program with the required criteria.
- f. Resolve/ Guide the students on technical/ non-technical issues faced during the project execution.
- g. Conduct industry webinars/ talks, hackathons, workshops, etc., at the respective innovation hub for the students.
- h. Based on the merit, PYGENICARC would assist conversion of ideas to prototypes of students who have undergone training by PYGENICARC.
 - i. Providing access to the best resources in the community and industry for the student innovators to build prototypes for the right ecosystem partner.

This in turn increases the innovation index of the institution – the number of ideas built, business pitches submitted, and processes shared with partnering colleges to build their research and innovation vertical – which will help them to enhance their NIRF, ARIIA ranking and also adhere to the NBA requirements.

4. RESPONSIBILITIES OF City Engineering College, Bangalore

- a. To bring to the notice of all students in the institution the offerings of PYGENICARC.
- b. To provide infrastructure support at your institution to conduct events and activities.
- c. Motivate and encourage the students to take up the program/ course/ workshop/ webinars/ hackathons conducted by PYGENICARC.
- d. To actively take part in the outreach/ discussion meets/ gatherings activities conducted by PYGENICARC for the institution.
- e. Quarterly feedback on the improvements shown by the students through the PYGENICARC program for the mutual benefit of the parties.
- f. To provide a Single Point of Contact who will be responsible for supporting the PYGENICARC team for smooth functioning. All reporting to the institution will be done through the Single Point of Contact.

5. COMMERCIALS

- a. City Engineering College, Bangalore will pay fees collected from the students enrolled for the PYGENICARC program on the agreed terms and will be limited to the amount approved for each program.
- b. The office of the Principal/ Finance officer will verify the bill submitted by PYGENICARC and make the payment on or before the commencement of the program modules
- c. Any change in the mode of payment needs to be mutually discussed prior and agreed upon by both Parties.

6. NO OBJECTION

Either parties are free to sign MoUs with multiple Companies, Government organizations and Educational Institutions and PYGENICARC and City Engineering College, Bangalore will have no obligations towards the same. The Agreement shall be subject to the jurisdiction of the courts at Bengaluru.

7. CONFIDENTIALITY

- a. During and for a period of 3 years, both the Parties shall keep confidential all knowledge, and information they acquire during their association. Such communication, information that is desired by the party sending the information to be kept confidential, shall inform the confidential nature of such information to the receiving party. Confidential information includes, without limiting the generality of the foregoing, information relating to intellectual property like courses offered, design of the courses, contents of the tutorials, webcasts, and podcasts, details regarding the fee payable, and/ or such other information to which the Institute may have access in the course of the association and terms of agreement which forms as part of this agreement.
- b. The obligations above shall not extend to any confidential information for which the receiving party can prove that this information:
 - is in the public domain at the time of disclosure or comes within the public domain without fault of the receiving party.
 - is already known or become known to the receiving party
 - is received from a third party having no obligations of confidentiality to the disclosing party
 - is independently developed by the receiving party; or
 - is required to be disclosed by law or court order.

8. NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

9. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 3 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MoU upon 60 days prior written notice to the other party. However, no such early termination of this MoU, whether mutual or unilateral, shall affect the obligations of the participants under any Research Agreement, Confidentiality clause as referenced in clause 7 above, or any other agreement entered into pursuant to this MoU, which obligations shall survive any such termination.

10. RELATIONSHIP

Nothing in this MoU shall be construed to make either party a partner, an agent or a legal representative of the other for any purpose.

The use of the name, logo and/or official emblem of any of the Parties on any publication, document and/or paper or marketing collateral is allowed with prior permission by either party.

11. ASSIGNMENT



It is understood by the Parties herein that this MoU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

12. SIGNED IN DUPLICATE

This MoU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.




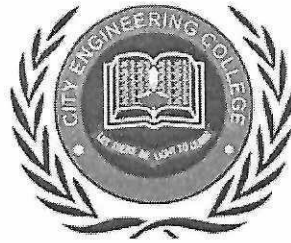

MOU MEMORANDUM OF UNDERSTANDING:

NOW therefore the **two parties** have agreed to cooperate as follows:

PARTIES

This Memorandum of Understanding (hereinafter referred to MOU) is between **City Engineering College**, with an address of Doddakallsandra, off Kanakapura Main Road, Bangalore -560062, Bangalore, Karnataka, India and **Avriant Private Limited – UNITE**, with an address of #1c, 6th cross, 2nd floor, 3rd block Jayanagar Bangalore, Karnataka 560011,India and #10 Claremont Street Worcester MA Boston 01610,USA Collectively referred to as the **“Parties”**.

PURPOSE

- The purpose of this MOU between City Engineering College and Avriant Pvt Ltd – UNITE is to help students with industry tech skills which help increase the employability job opportunities in Students.
- While bridging the gap between the college and corporations, this program is intended to provide successful placement assistance.
- Transitioning the students into Industry skilled professional, who are ready for the employability during/post-graduation.
- Students will gain professional etiquette from working professionals and industry SME’s across the globe.

PRELIMINARY DISCUSSIONS

The two parties have discussed the possibilities for collaboration, including (details refer - “Professional Program Annexure”), subject to negotiation of the appropriate contractual terms and to the necessary funding being available.

WHEREAS the **City Engineering College** has objectives as to provide the best learning facility to students and one of the top-notch colleges in Karnataka. It is the institute of excellence in engineering education and research, producing socially responsible professionals. Creating a conducive environment for learning and research. Establishing industry and academia collaborations. Ensuring professional and ethical values in all institutional endeavors.

WHEREAS the **Avriant Private Limited – UNITE**, our mission is to empower students through technology education and bridge the gap between college and the corporate world. We provide comprehensive technical skills that equip students with the necessary skills, knowledge, and industry exposure to succeed in their careers. Through expert guidance, practical training, and networking opportunities, we strive to unlock their full potential and help them transition seamlessly into a professional career.

WHEREAS **both** institutions desire to establish relations in **College to Corporate** transition of Students. The program is built around Industry Based Course curriculum for students, which will increase / accelerate the employability of the students before they graduate.

ADMINISTRATIVE RESPONSIBILITIES - Avriant Pvt Ltd - UNITE

- Prior to Admission, provide an orientation program for incoming students.
- Register the students for the duration of the Professional Certificate Program.
- Create the academic credentials of students who would like to participate in the program.
- Provide the names of courses that are essential to students' curricular plan.

- Endeavour to ensure that students are admitted to courses regarded as essential to their academic program.
- Assigning an academic advisor to all incoming students.
- Conducting effectively professional course module successfully, across all the semesters for Eng and Master students.
- **100 % placement assistance to all the students registered for his professional certifying course college to corporate course transformation.** Reciprocal placement assistance of students in paid/unpaid internships and co-ops.
- Provide the CITY ENGINEERING COLLEGE with a final transcript of the student's academic performance at UNITE (Joint supervision of Postgraduate projects).
- Both institutions further agree to bear the cost of administering the program on such terms as shall be mutually agreed upon from time to time.
- The total cost of each course will differ according to the location of the host country and the nature of the course being taught.
- Joint conferences and workshops.
- Online, Hybrid Classes with National International Industry Experts and Professors, Subject Matter Expertise.

FINANCIAL PATTERN

- Both Parties understand that all financial arrangements between the Parties have mutually agreed.
- The Fund will be collected from students during Admission or from the admission fund or individually based on CITY ENGINEERING COLLEGE decision.
- Prior participation in the program, Students should have been paid Tuition and fees to CITY ENGINEERING COLLEGE.
- Payment will be made to Avriant UNITE, split across monthly.

LOGISTIC REQUIREMENT UNDERSTANDING

- Required dedicated space for UNITE COE (Centre of Excellency) team.
- We will be utilizing all the amenities of the college for facilitating the program on need basis (ex: Library, Computer Labs, Seminar halls, Projectors, Audio-Video Conferencing Equipment)

COMMENCEMENT, RENEWAL

- This MOU will be effective from the date of the signature hereto
- And will remain in force for a time period of five years, with a possibility for renewal at the end of the five-year-period, subject to the Parties' written agreement.

TERMINATION OF MEMORANDUM

The memorandum of Understanding may be terminated with immediate effect by mutual agreement between the parties or by either party giving the other not less than six months' notice in writing.

LIMITATION OF LIABILITY

Except for loss or damages caused through gross negligence or intent, the Parties shall have no liability to each other hereunder. Under no circumstances will either party be liable for any indirect, special, consequential, or punitive damages (including lost profits) arising out of or relating to this Agreement or the transactions it contemplates (whether for breach of contract, tort, negligence, or other form of action) in case such is not related to the direct result of one Party's negligence or breach.

ASSIGNMENT

The Parties hereby agree not to assign any of the responsibilities in this Agreement to a third party unless consent to by both Parties in writing.

SETTLEMENT OF DISPUTES

The parties shall first use reasonable endeavors to amicably settle disputes arising out of or in connection with this Collaboration Agreement. Where a dispute has not been amicably resolved the parties shall enter structured negotiation with the assistance of a mediator acceptable to both sides. 



Ltd, a company incorporated under the laws of India, having its registered office at **SK Complex, Uttarahalli Main Road, 5th Stage RR Nagar, Bengaluru, Karnataka, 560098**, <https://ipecsolutions.com/>, represented by its Director, **Mrs. Fathima Afroz** (herein after referred to as the “**Company**”, which expression, unless repugnant to the context and meaning therein, shall mean and include its successors, representatives, nominees and assigns).

The term “**Company**” and “**Department**” are individually referred to as such or a “**Party**” and collectively referred to as the “**Parties**”.

WHEREAS

A. The Company, an Industry, established in the year 2019 and engaged in the business of Software development, design thinking, technology transfer, research and development as well as training cutting edge technologies.

B. **Computer Science & Engineering and Information Science & Engineering**, is an established department under **CITY ENGINEERING COLLEGE**, Bengaluru which strives to enhance and strengthen its Industry-Institute Interaction and has taken various initiatives to complement its educational excellence to meet the industry needs, has entered into various collaborative arrangements with other parties to enhance the knowledge and skills of the students in the Artificial Intelligence, Machine Learning and Data Science, Cyber Security discipline.

C. The Parties are desirous to enter into this MOU to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

1. AREAS OF COLLABORATION

2.DURATION AND TERMINATION

For purposes of this MOU, “confidential information” means any information whether prior to or hereinafter disclosed by a Party(the Disclosing Party) to the other Party(the Receiving Party) of this MOU involving technical, business, marketing, policy, know-how, planning, project management and other information, data and/or solutions in any form, including but not limited to any information which is designated in writing to be confidential or by its nature intended to be for the knowledge of the Receiving Party or if orally given, is given in the circumstances of confidence.

5. REVISION, VARIATION AND AMENDMENT

Either Party may request in writing a revision, variation or amendment of this MOU. Any such revision, variation or amendment agreed to by the Parties shall be in writing and shall form part of this MOU and shall come into force on such date as may be determined by the Parties.



6. INTELLECTUAL PROPERTY RIGHTS

Any information or project material or the like in the public domain shall not be part of this commitment. CEC and EIT are jointly bound by the general rules and regulations of the establishments with whom the projects are being executed.

5.4 In written whereof both parties put their hard seal on the day, month and year herein mentioned.



And whereas, the Parties seek to collaborate with each other to mutually complement their synergies and to jointly work on building capacity of learners through one or more of the programs managed by Edunet.

Now therefore, this **Memorandum of Understanding** (hereinafter called "**MOU**") witnesses the following.

- 1. Term and termination:** This MOU is valid for an initial term of 5 years from the Effective Date. It can be extended by further periods, as agreed to by the Parties from time to time. Either Party may terminate this MOU by giving the other minimum 30 days' notice. - 4. Single Point of Contact (SPOC) for program co-ordination:** Both the Parties shall appoint a suitable


